Washington State Dental Laboratory Registration Discussion

On Friday, April 19, 2019, Governor Jay Inslee signed the WSDLA Dental Laboratory Registration Bill into law. This new law creates a dental laboratory registry within the Department of Health and requires that:

All dental labs servicing dentists in the State of Washington must:

1. Register with the Department of Health
2. Disclose to the dentist materials used in the device
3. Disclose to the dentist the city, state and country where the device was made

In addition, effective January 31, 2021:

1. The owner or an employee must complete 12-hours of NBC-approved continuing education annually

Finally, by January 31, 2025:

1. The owner or an employee must be a Certified Dental Technician in good standing with the National Board for Certification

WSDLA is currently working closely with the Department of Health determining how this bill will be implemented and to help ensure the responsibilities of laboratory owners are easy to implement and comply with this new law.
